#### **Tree Preservation Orders (TPO)**

Any tree put forward for a Tree Preservation Order (TPO);

Must be first assessed by the local planning authority as being an important landscape feature offering significant amenity to the general public.

Usually needs to be under an immediate or foreseeable threat to warrant protection.

## Felling License Required.

A felling license is required by law if you fell more than 5 cubic meters square in one calendar quarter. Contravention to the regulations is to be reported via a local Forestry Commission Office:

## **Tree Planting**

Tree planting should be carried out when the tree is dormant. This means that there are no fixed dates that define exactly when it is appropriate to plant. The 'Planting Season' usually lasts from around mid-November to early March, but this will depend on the site and weather conditions.
